## Air Conditioning Rebates and Financing for ACE Customers

Rebates up to \$1,000 and Financing up to \$5,000\* when paired with Gas Measure

Upgrade to qualifying equipment and you may be eligible for rebates and incentives from New Jersey Natural Gas (NJNG), including 0% APR financing for seven years through NJNG's On-Bill Repayment Program (OBRP).\*

Replace what you need now and return later to access even more rebates and incentives for additional equipment upgrades. Enhanced rebates and financing options are available for income-eligible customers.
