

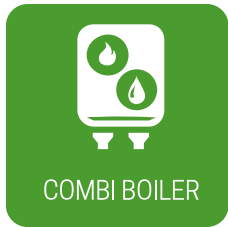

Boiler Equipment Rebates and Financing

Rebates up to \$1,750 and Financing up to \$8,500*

Upgrade to qualifying equipment and you may be eligible for rebates and incentives from New Jersey Natural Gas (NJNG), including 0%* APR financing for seven years through NJNG's On-Bill Repayment Program (OBRP). Replace what you need now and return later to access even more rebates and incentives for additional equipment upgrades. Enhanced rebates and financing options are available for income-eligible customers.

Indirect coupled with greater than or equal to 95% AFUE boiler	Finance up to \$8,500	And/Or	\$1,300 NJNG Rebate
Combi unit with greater than or equal to 97% AFUE	Finance up to \$8,500	And/Or	\$1,750 NJNG Rebate
Qualifying water heater coupled with greater than or equal to 95% AFUE boiler	Finance up to \$8,500	And/Or	\$1,500 NJNG Rebate

Note there is a financing cap on each boiler (see above). All loans are net NJNG rebates.

NJNG bonus incentive is available for income-eligible customers.
